





Yearly Donation Growth








SUPERINTENDENT'S GALA

DCEF was pleased to be asked by Superintendent Trent North to partner with him in the inaugural Superintendent's Gala, a memorable evening of dining, dancing, and networking with business, community, government, and school system leaders. The sell-out event's theme was Great Gatsby and raised over **\$45,000** for out-of-classroom experiences for students enrolled in Special Education classes. A portion of the proceeds were used to establish an endowment to provide grants to students for generations to come. The remaining \$12,000 was dispersed to schools that have Special Education classes.


